PERSONAL GUARANTY

The undersigned Guarantor ("GUARANTOR") hereby requests The Crawford Supply Group, Inc., a Delaware corporation, its parent subsidiaries, affiliates, divisions, successors and assigns (collectively, the "COMPANY") to extend credit for the purchase of merchandise, or permit credit to remain outstanding to

with principle offices located at _____ ("DEBTOR"), as the COMPANY may, in its sole discretion, extend or permit, from time to time. To induce the COMPANY to grant or extend such credit, GUARANTOR hereby unconditionally, irrevocably and absolutely guarantees, the full and prompt payment, when due, of all obligations of DEBTOR to the COMPANY or any related entity, now or hereafter existing and any and all expenses, including reasonable attorneys' fees paid or incurred by the COMPANY in endeavoring to collect such obligations or any part thereof, or in enforcing this Guaranty, both against DEBTOR and GUARANTOR (collectively, the "Obligations"). This Guaranty shall remain in full force and effect until *thirty (30) days* after revocation in writing from GUARANTOR is actually received by the COMPANY. This is a continuing guarantee of payment and not of collection and remains effective whether the indebtedness is from time to time reduced, later increased, entirely extinguished or later reincurred, such revocation shall be effective only with respect to such Obligations of DEBTOR arising after *thirty (30) days* on which such notice is actually received by the COMPANY, and this Guaranty shall remain in full force and effect as to all Obligations existing on the date such notice is received until the full payment of such Obligations to the COMPANY.

GUARANTOR hereby expressly waives: (a) notice of acceptance by the COMPANY of this Guaranty; (b) notice of the existence or creation or non-payment of all or any Obligations; (c) presentment for payment, notice of presentment protest and demand, notice of protest, dishonor, non-payment, release, compromise, settlement and extension or renewal of the Obligations; (d) *any right to require COMPANY to institute suit against DEBTOR or exercise any rights or remedies against DEBTOR or exhaust any security, it being understood and agreed by GUARANTOR that its liability hereunder shall be in all respects absolute and unconditional*; and (e) all diligence in collection or realization upon the Obligations or any part thereof. GUARANTOR acknowledges that no delay on the part of the COMPANY in the exercise of any right or remedy in endeavoring to collect the Obligations or in enforcing this Guaranty shall operate as a waiver thereof and no single or partial exercise by the COMPANY of any such right or remedy shall preclude other or further exercise thereof or the exercise of any other right or remedy, nor shall any modification or waiver of any of the provisions of this Guaranty be binding upon the COMPANY, except as expressly set forth in writing, duly signed and delivered on behalf of the COMPANY. GUARANTOR further acknowledges that the execution and delivery of this Guaranty to the COMPANY was a material inducement to the COMPANY's grant, extension or continuation of credit to DEBTOR. This Guaranty shall be binding upon GUARANTOR and GUARANTOR'S heirs, legal representatives, successors and assigns. This Guaranty shall be governed and construed in accordance with the laws of Illinois.

The COMPANY may, from time to time, whether before or after any revocation or discontinuance of this Guaranty, without notice to any GUARANTOR., assign or transfer any or all of the Obligations or any interest therein; and, notwithstanding any such assignment or transfer or any subsequent assignment or transfer thereof, such Obligations shall be and remain Obligations for the purposes of this Guaranty, and each and every immediate and successive assignee or transferee of any of the Obligations or of any interest therein shall, to the extent of the interest of such assignee or transferee in the Obligations, be entitled to the benefits of this Guaranty to the same extent as if such assignee or transferee were the COMPANY.
